# 1.0 Editing and Branding the Product

#### 1.1 Branding the E-Book

#### What You MUST Do

- 1. Open the product's Word document found in the /Source Files (Do Not Upload) directory using your Word program.
- 2. You can edit the product contents such as:
  - ✓ Put your name as the author,
  - ✓ Insert your advertisements and affiliate links,
  - ✓ Replace the E-Cover,
  - ✓ Etc.

When you're done, convert the Word document into PDF format using your PDF Converter program. If you don't have one, I recommend <a href="OpenOffice">OpenOffice</a> or <a href="PrimoPDF">PrimoPDF</a>.

#### **Branding Tips**

1. You can change the flat E-Cover design on the first page of the product to another E-Cover of your choice. You can edit or re-title the E-Cover's

Photoshop Source Document (PSD) in Adobe Photoshop program, save it, and later use as your flat E-Cover in Word document.

- 2. You can brand every page with your website URL in the header or footer. To do this, go to View -> Header & Footer in your Word program (Microsoft Word). Then, you can insert your name and/or website URL.
- 3. You can insert your links/affiliate links and recommend to your readers throughout the product (E-Book). The last pages of the E-Book (Recommended Resources) are ideal spots where you can insert your own recommended resources and affiliate links as good follow-ups for your customers, enabling you to earn back-end income for you.

#### 1.2 Editing the E-Covers

The covers can be found in the /Cover directory. If you want to edit the E-Covers i.e. change title, add in your name, etc. open the PSD files in **Adobe Photoshop** and save them as .JPEG or .GIF format.

If you don't have Adobe Photoshop program installed in your computer, you can purchase the latest version of the professional paint program you're your nearest computer store or online:

If you merely want to change the color schemes, there are over 4 different color schemes to choose from.

#### 1.3 Editing the Sales Letter

- Open your HTML Editor or Notepad.
- 2. **Open the index.htm file** found in your /Sales Letter folder.
- 3. There are pink tags written [Insert Your Name Here] in the sales letter. Be sure to color the text **black** or (any other color you prefer) and replace the text with your name/pen name.
- 4. Add the order link to the order button in the sales letter (usually found at the bottom). If there are "http://orderlink/" hyperlinks present in the sales letter, replace it with your order link, too. You can now start accepting payments online from customers who want to purchase the product from you!

(Also applies to the Private Label Rights sales letter titled **index-plr.htm**.)

<u>Tip:</u> You can easily change the color schemes of the sales letter. For example, if you want to use the color schemes found in the /Sales Letter/images2 folder, simply rename the folder to "images". Before that, rename your original "images" folder to another name e.g. "images1". The changes will take effect immediately when you open your **index.htm** file.

#### 1.4 Editing the Thank You Page

This is the page your customers will come to after they make payment via your payment processor.

The Thank You page is titled **thankyou.htm** found in the /Sales Letter folder.

**Important!** Rename the Thank You Page file to another name *e.g.* thankyou777.htm. The filename thankyou.htm is not only generic but too easy for visitors to guess so they can gain access to your Thank You page for free.

- 1. Open the Thank You page in your HTML Editor or Notepad.
- 2. Replace the pink tag [Insert Your Email Address] with your email address.
- 3. Replace [Insert Your Name Here] tag with your name.

<u>Tip:</u> You can include ads in this page for back-end selling, or another opt-in form to collect quality customer leads for future follow-ups.

#### 1.5 Editing the Private Label Rights Sales Letter

(**Optional**: refer to this section only if you are releasing the PLR /+ Master Rights to this product.)

 Open index-plr.htm in your HTML Editor or Notepad, also found in the /Sales Letter folder. 2. Refer to Section 1.3 for subsequent editing steps.

# 1.6 Editing the Private Label Rights Thank You Page

(**Optional**: refer to this section only if you are releasing the PLR /+ Master Rights to this product.)

**Warning!** Not to be confused – the Thank You page for offering Resell Rights/ Master Resell Rights to the product is the **thankyou-plr.htm** file found in the /Sales Letter folder.

- 1. **Open the thankyou-plr.htm page** in your HTML Editor or Notepad.
- 3. Refer to Section 1.4 for subsequent editing steps.

This is the page your customers will come to after they make payment via your payment processor. This is where they will download the Resell Rights version of this product.

<u>Tip:</u> You can include ads in this page for back-end selling, or another optin form to collect quality customer leads for future follow-ups.

# 2.0 SETTING UP

#### 2.1 Domain Name & Web Hosting

If you haven't secured a domain name yet, get one now – it's essential!

#### **Recommended Domain Name Registrants**

Next, you need web hosting to host all your files.

Recommended all-in-one Solution: you can get all of your Internet Business necessities such as domain name, unlimited web hosting, file upload manager, pop-up generator, PDF Converter, unlimited auto responders, and more at SOLOBIS for a low monthly fee. This way, you can save money, time and effort from sourcing all the tools you need ala carte. You are not required to have any experience in programming and designing either to utilize the tools within this suite.

# 2.2 Setting up Your Merchant Payment Processor

You need a payment processor to accept online payments.

#### **Top Recommendations**

<u>2CheckOut.com</u> – start accepting credit card payments from customers from several parts of the world!

**Important!** When you create your product item within the payment processor, be sure to link to the appropriate Thank You page URL. You won't want your customers to see 404 error pages after making an eager purchase!

Also, be sure to update your sales letter with the order links as well.

#### 2.3 Uploading Your Files Online

You can use the file manager (if your web host offers this program) or FTP program to upload your files to your web host server. I recommend <u>WS FTP Pro</u> for this purpose.

Upload ALL the files in the /Sales Letter folder except the following files & folders:

• All the files found in "Source Images (Do Not Upload)" folder.

That's it. Do a last minute spot check at your web site to see if everything is in working order and you're ready to go!
