## **Terms And Conditions**

- **2. We do not** make any guarantees that you will earn any money with any of the products in the "Niche Beast" package, your income will depend solely on your own efforts. It is impossible for us to guarantee that you will make any amount of money with this Private Label Rights package. Simply because we do not know you, we do not know how hard you work, how much effort you will put into your business or your skill level.
- **3. You are responsible** for providing customer service to your own customers.
- **4. You may not** put our names (Dima Sorokine, Max Rylski, Dustin Struckman) on any of the products included in this package or use our names in any way to help you sell anything.
- **5. You may not** give away our contact information to any of your customers. **Again:** you are responsible for customer support for your own customers.

## 6. Selling Private Label Rights:

You may sell "Private Label Rights" to any one of the 12 products in the "Niche Beast" package. However, some conditions do apply:

<u>You may NOT</u> give away, trade or include as bonuses the Private Label Rights to any of the products included in the "Niche Beast" package. In other words: the Private Label Rights must be sold and can not be given away for free.

<u>You may NOT</u> sell Private Label Rights to more than two (2) products at a time or sell Private Label Rights to more than two (2) products on one website.

This means that if you want to create a website that sells "Private Label Rights" you may only include a maximum of two (2) products from the "Niche Beast" package.

And if you are planning to offer the Private Label Rights to any of the 12 products in the "Niche Beast" package to **your opt-in list:** 

**You may ONLY** make one (1) offer per week and each offer **may NOT** include more than two (2) products at a time.

<u>You may NOT</u> sell Master Resell Rights to more than four (4) products at a time or sell Master Resell Rights to more than four (4) products on one website.

This means that if you want to create a website that sells "Master Resell Rights" you may only include a maximum of four (4) products from the "Niche Beast" package.

Also:

The Master Resell Rights are not transferable which means your customers **may NOT** sell "Master Resell Rights". They may however sell regular Resell Rights.

Furthermore, when selling Master Resell Rights to any of the products in the "Niche Beast" package you are NOT allowed to include absolutely everything the products come with:

<u>You may NOT</u> include the **PSD source files**, **Key Word Lists** or **MS Word source files** when selling any one of the 12 products that come in the "Niche Beast" package.

**8.** You may not market this product in any illegal, immoral or unethical manner, including the use of spam (unsolicited commercial email) and off-topic newsgroup or discussion forum postings.
